Notification of the Scope of Services During Service Commissioning

I. Scope of Services During Service Commissioning

- 1. The activity that the business carrying out the retail business entrusts the sale of the article to another business
- 2. When a business with transportation is entrusted with the following activities to other transportation companies (logistics suppliers, port operators, railroad carriers, etc.)
 - A. Under the Cargo Distribution Promotion Act, a logistics business operator or a multimodal freight forwarder entrusts the transportation, storage, unloading or packing of goods pursuant to Article 2, Paragraph 1 and all other activities related thereto, or arranges for the transportation of goods pursuant to Article 2 Charging Activity
 - B. In the Port Transportation Business Act, the Port Operator entrusts the Port Service pursuant to Paragraph 1 of Article 2 and the Port Service Business of the Port-related Business of Article 2 (4)
 - C. Activities in which railway transporters, such as the Korea Railroad Corporation, entrust the transportation business under Article 9 (1) 1 of the Korea Railroad Corporation Act

- 3. A business entrusted with the sale of real estate, such as a building owner, pursuant to Article 2, Paragraph 1, Item 12 of the Building Act, entrusts other business operators with the sale of the building under the provisions of Article 2, Paragraph 2 of the Act on the Sale of Buildings
- 4. If a software provider pursuant to Article 2 (4) of the Software Industry Promotion Act entrusts the following activities to another business operator (except for the "information program" under Article 2 (12) 1 of the Act on Fair Trade in Subcontracting Transaction do)
- A. Businesses engaged in computer-related services are entrusted with consulting, requirements analysis, system integration testing and installation, operation and maintenance of the system for a certain period of time
- B. Activities in which a company that produces database creation and retrieval services entrusts tasks such as storing data in a computer's storage device or searching or providing data
- 5. When an advertising business is entrusting the following activities to another business
- A. Activities that entrust promotions, events, research, and consulting related to advertising
- B. Activities entrusting editing, presenting, recording, shooting related to video advertising
- C. Activities entrusted with research, planning, design and composition related to exhibitions and events
- 6. Activities in which a company operating in broadcasting and broadcasting production, film production, and performance planning entrusts other companies with editing, development, recording, photography, sound, lighting, auxiliary performance, or creating art works
- 7. The entrustment of the services provided by the above listed entities entrusts all or part of the entrusted services to other entrepreneurs

II. Review Period

In accordance with the provisions of the 「Regulations on the issuance and management of directives and regulations」 (Presidential Ordinance No. 248), the time limit for the abolition of the notification, August 20, 2015 shall be held.
